Completed Cantos 5 must be sent within 48 hours of the initial report to the nearest local DCFS Office by us Prepaid Postage Mail. "What is negligence? Negligence occurs when a person responsible for the child deprives or does not provide the child with adequate food, clothing, shelter or medical treatment. "What are the penalties for not making a required report? Voluntary failure to report suspected incidents of child abuse or neglect is a misdemeanor (first) or a Class 4 felony (second or subsequent). Requirements and Procedures An employee, volunteer or student who is a mandatory reporter and who has reasonable cause to believe that the abuse or neglect has occurred with respect to a child known to the employee or the student in his or her professional capacity, must immediately inform the DCFS that he or she believes that a child may be abused or neglected. This initial report can be made by telephone at the DCFS free child abuse hotline number: 1-800-25A-BUSE (1-800-252-2873). The signed form will be kept on the staff, volunteer or voluntary file of the obligatory reporter. In addition, an employee who does not make a report may face disciplinary action, up to and including termination. This can happen when children are left unsupervised or in the care of someone unable to supervise due to their condition. If the individual is suspected of abuse or neglect, being the Director, Human Resources, will be awarded a copy of Songs 5, will be awarded to the VP, student development and support services. In cases where the individual suspected of abuse or neglect is an employee, volunteer or student, and where an incident occurred on university property or was carried out in connection with a university-sponsored or recognized program or activity, the reporter should notify the college as noted above. Internal notification is subject to the discretion of the reporter. A member of the behavior intervention team will assist the reporter in further compliance with these procedures if the reporter requests assistance. If the direct line intake worker does not accept your call as a report, you will be informed of that fact and given the reason. In June 2012, the Child Reports Act And carelessness (Anca) was modified to include all personnel of higher education institutions as mandatory reporters.
